The consistency check confirmed that the transportation indicator information used to build the metric is consistent with indicator information reported to the <b>Federal Transit Administration's National Transit Database</b>. The consistency check was completed to a 5 percent materiality (95% consistency) threshold. Verification of the GHG emissions was conducted in accordance with The Climate Registry's General Verification Protocol.</p>
