

The negotiated Compensation falls within an acceptable competitive range which is \$35 to \$40 per square foot, as determined by an independent broker's opinion of value.

MTA Real Estate entered into a License Agreement pursuant to the "Amendment of Negotiated License Policy for Existing Tenants" approved by the MTA Finance Committee and Board on July 22, 2020. This transaction classifies as a permitted renewal of a license agreement with an existing Licensee in good standing and is presented to the MTA Finance Committee and Board as an information item.

LIRR acquired an approximately 5.33-acre parcel in the Town of Brookhaven in Suffolk County, NY in support of MTA C&D's project to construct a new station and relocate the existing LIRR Yaphank Station. The current Yaphank station is in a sparsely populated area and sees a low level of service. The relocated station will better meet current and future ridership demands of central Suffolk County. The Premises was appraised and valued \$2 million and acquired from the Seller for no compensation as the site also benefits the Seller's future adjacent development plans.

The Premises was acquired pursuant to MTA Board Policy, dated September 15, 2015, and modified July 19, 2023, which allows MTA Real Estate to acquire property rights in support of MTA capital projects without MTA Board approval when aggregate compensation is less than \$100,000.
